**Call to Order and Opening of Meeting**

**Suzanne Kavanagh**

The meeting was called to order at 7:05 pm. Lori Lytle was appointed as recording secretary. Amendment to Agenda: due to illness, the presentation by Clyde Wagner was moved to the beginning of the schedule, followed by regular business.

**1.0 Guest Speaker – Clyde Wagner, CEO and President, Civic Theatres Toronto**

Clyde Wagner became the first CEO and President of Civic Theatres Toronto in January 2017. He discussed the amalgamation process of the three theatres concerned (Sony Centre, St. Lawrence Centre for the Arts, and the Toronto Centre for the Arts), explaining that the restructuring would create one organization that operates all three buildings. He emphasized that the goal of this amalgamation is to maximize the potential for the three buildings as welcoming, innovative and creative spaces that serve and reflect the needs of the city of Toronto.

Mr. Wagner talked about the St. Lawrence Centre for the Arts specifically as a space that is underutilized and operating at a low 35% capacity. Civic Theatres Toronto is evaluating how to optimize the building's use as a creative space that is more accessible to the public, in the short term and also the much longer term.

His presentation concluded with a question and answer period, mainly focused on the issue of community/neighbourhood involvement with the theatre spaces. Mr. Wagner explained the importance of community engagement while staying within budget, and emphasized that the spaces belong to the community, and residents need to take ownership and bring their ideas to him.

Expenses of \$24,184 went to community donations, including \$20,000 to Heritage Toronto, as well as to other special events. The project costs of \$1,917 included gardening expenses and the senior's TV, and the Office and General costs of \$1,388 included marketing, as well as building and hosting the new SLNA website. The year-end balance is \$25,570.

The previous auditors declined doing an audit this year, therefore a new auditor will be sought and information will be reported when available.

It was noted that Association members have been involved in work related to the founding of Waterfront for All, and that representatives regularly attended meetings for the Gardiner Environmental Assessment, the West Don Lands, and the St. Lawrence Market Precinct Advisory Committee. The SLNA also supported the naming of Reg Taylor Way. Suzanne Kavanagh mentioned that she will appear as a witness in the Licensing Tribunal for the Rebel night club.

The SLNA donation to Heritage Toronto supported four historical plaques, marking the "Original Ten Blocks of the City", 17 Toronto Street, the Young People's Theatre, and the cholera epidemic in St. James Park.

Suzanne Kavanagh announced that the new SLNA website will be going live on Friday, March 31, 2017 at [www.slna.ca](http://www.slna.ca). She asked members to help with editing the site, and encouraged them to add to the Event Calendar.
