# 2. Opening Of Meeting

#### 2.1 Opening Remarks

Suzanne Kavanagh (President) stated that she would be chairing the meeting and called the meeting to order at 7:00 p.m.

### 3. Board Meeting Update:

- Suzanne Kavanagh represents SLNA on???. Information, for delegates input/comment will be on the SLNA website.
- Development at 25 Ontario will incorporate Development Committee recommendations
- February 13<sup>th</sup> met with Sandra Shaul about the planned War of 1812 Bi-centennial celebrations.
   Request for SLNA community input was sought. Discussions are underway.
- February 14 & 17 participated in the presentations on the Tall Buildings Report which was approved
- BIA won an award from 8 80 Cities for Berczy Park revitalization
- Board is pleased with annual membership drive: all but two residences have renewed their membership

Suzanne Kavanagh brought forward a motion for the board to allocate no less than \$20,000 to purchase benches/trees for the neighbourhood in celebration of the SLNA 30<sup>th</sup> anniversary. The **motion was carried**.

### 4. Announcement - Toronto's First Post Office

- Janet Walters, First Post Office Heritage Society, announced that 11 memberships in the Town of Old York Historical Society were taken out in response to the challenge for 40 memberships from SLNA members
- The society's celebration of Toronto's birthday is now in its 8<sup>th</sup> year. The theme for this year ties in with the Bi-centennial celebrations and will be held at St. Lawrence Hall.

#### 5. Update on the North Market

Alan Seymour and Cheryl Baker provided an update on the status of the much anticipated North Market redevelopment:

- Planning for the north market revitalization goes back to 1998
- The north market will be temporarily located to the parking lot south of the south market January 2013
- Ground breaking January 2014
- Completion December 2015
- There will be parking for about 250 vehicles
- Cost capped at \$75 million
- The building is four stories occupied by Courts with the Saturday and antique market on the first floor
- An advisory group is being formed to advise on governance and programming. Membership is expected
  to number 12 -16 and will be drawn from stakeholders and the community with representation from
  across the city
- Truck parking will be addressed
- Pam McConnell noted that the Seniors' Centre will be incorporated into the facility and that there is \$1 million in section 37 monies held for the centre.

# 6. Discussion on Toronto City 2012 Budget:

Pam McConnell provided an overview of the budget:

- The City is not permitted to run a deficit or to borrow to meet a shortfall: unlike other levels of government it must approve a balanced budget. Of every tax dollar, .08 is directed to municipalities with .50 to the federal and .42 to the provincial government.
- Direction provided included cut spending through efficiencies and service level adjustment; maximize revenues; moderate impact on capital improvements, and moderate TTC and property tax increases.
- Pressures included provincial downloading, repeal of Vehicle Registration Tax
- Where the money goes about 1/3 of the operating budget covers police and emergency services and TTC and another 1/3 to provincially mandated programs such as child services
- Where the money comes from about 40% from property tax and about 20% from the federal and provincial governments
- The capital budget is allocated to infrastructure repairs (57%) and new infrastructure related to growth (28%)
- The St. Lawrence neighbourhood has benefited significantly Union Station revitalization (\$411 M);
   Donlands/Queens Quay (\$137M); St. Lawrence Market (\$72 M); Regent Park Community Centre (\$17M);
   Regent Park Aquatic Centre (\$4M); and, St. Lawrence Library expansion (\$18M)

#### Discussion included:

- The BIA has been instrumental in Berczy and St. James Park development. Funds have been levied from L Tower, Backstage and 40 Scott Street condo developments. Jane? from the BIA reported that the 8-80 Cities award is \$50,000 in assessment and design expertise for the parks. It is being supplemented by \$9,000 from the BIA
- Other South Market improvements include Market Street revitalization for both the Woodcliffe development and the market building
- Jarvis and Front Street improvements will be underway shortly. Some funding provided through Section 37 monies from Market Wharf development

## 7. SLNA Board Nominations

Alan Seymour reported on the nominations process and issued the call for nominations:

- Elections will be held at the next delegates meeting on Wednesday, March 28, 2012
- Nomination forms are available from Jacquie Williams
- Nominations and voting is restricted to delegates and the Member Profile must be completed and submitted to Jacquie prior to the meeting. The form is available on the SLNA website.
- There are now 44 member building with 114 delegates

#### 8. New Business

- Ronny Yaron announced that a local business involved with bicycle repairs will be moving into the vacated space on Jarvis Street South.
- Ronny Yaron thanked Lois and Margaret for the excellent cookies
- Loretta Allen announced that planning is beginning for the annual SLNA Canada Day Celebrations and issued a call for volunteers to identify themselves to her.
