2.3 Board Meeting Highlights

Suzanne Kavanagh updated the Delegates with the following information from the Board meeting:

- Presentations for July Delegates Meeting:
 - Rollo Myers First Parliament Site
 - Cindy Wilkey West Donlands
 - o Bonnie Taylor Toronto Marathon and Buskerfest
- Sugar Beach is open
- The park at the bottom of Sherbourne is called Sherbourne Common
- The Red proposal won for the North Market
- The Board will ask the new buildings being constructed if they are going to join the SLNA, the Queen's Quay Neighbourhood Association or form their own association
- Hand wells are being replaced by Toronto Hydro
- Following up with Pam McConnell's about the asphalt being replaced with concrete
- Survived the G20 Summit, however some Delegates from the west end of the Esplanade expressed outrage that they had to identify themselves to police officers
- Mayoralty Debate with the first six candidates is being scheduled and inviting Gooderham and Worts and Corktown Associations to join
- Proposals for 154 Front St. East (Greyhound Bus Parcel Terminal) closed June 30th
- Q. Will they do something with the land?

3. TORONTO CENTRE M.P.P.:

- Chris Drew, Community Planner in Glen Murray's office provided regrets from Glen Murray who was double booked by his staff to attend a Pride event
 - Concerned about G20 Security concerns and the powers given to Toronto police. They are looking into preventing this from happening again. Please contact the office as they are collecting information.
 - Interested in the fact that the federal government removed money from the Charter Challenge fund. It is important that citizens can access this fund.
 - Passionate about Community Planning and will be working with communities to create a "Toronto centre community action plan" that will map resources and gaps so that critical issues in the riding, such as affordable housing, can be addressed.
 - Passionate about working together to create long term sustainable solutions. Looking to be more
 proactive and thinking about long term strategies. For instance, would like to use Provincial
 owned land in the riding for the community benefit and to create a set of priorities with the
 communities to work on for future.

While there were many suggestions, because of the strict guidelines from the City, not all names were accepted. The committee anticipates that these recommendations will get to Council by early next year. The BIA for the St. Lawrence Neighbourhood wants to kick in extra dollars to add to the branding of the signage. As a result, this will be turned over to the BIA. The committee does have some other names if needed.

- A. Do not want to continue this process as it has been discussed since March.
- Q. Are the names cast in stone or is there room for suggestions?
- A. SLNA delegates were advised and invited to contribute will now be moving forward with the suggestions.

- Will be involved with the Municipal Elections by assessing each candidate's position on the 6 priorities
- Major achievement Green Bins and Pesticide ban and Community Right to know bylaw with support from associations such as SLNA
- Six Priorities:
 - o Build Transit City and Fund It accessible transit for priority neighbourhoods
 - o Achieve 70% Waste Diversion by 2012 green and blue bins in all areas and buildings
 - Buy and Support Locally Produced Green Products retrofit old buildings and create jobs in the community
 - Build Transportation Infrastructure Everyone Can Use support bike lanes and make them accessible
 - Implement the City's Sustainable Energy Strategy all new buildings will be green and sustainable and keep Toronto Hydro public and accessible
 - **Provide Tools to Prevent Pollution** extend the breadth of responsible reporting and reduce pollution
- **Next Steps**: Obtain SLNA, along with other community associations, endorsement of the six priorities; assessing the top six candidates for Mayor; asking individuals to endorse these priorities as well
- Q. Tell us about your organization.

- A. No. Live Green may do this.

This laneway is private property and as such is not policed by the City. The SLNA has tried for four years to address these issues. Recommend getting representatives together from each building and raise concerns to Pam McConnell's office.

Dogs – Could we put fencing up and allow dogs to go in the park? The Board will discuss this suggestion further.
