#### 2. OPENING OF MEETING

#### 2.1 Opening Remarks

Suzanne Kavanagh (President) stated that she would be chairing the meeting and called the meeting to order at 7:03 p.m.

# 3. GUEST SPEAKERS: GEORGE BROWN COLLEGE - COMMUNITY PARTNERSHIPS

Kizzy Bedeau, Operations Manager and Joseph Stapleton, Community Projects Manager from the Community Partnerships Office of George Brown College presented:

Overview: Community Partnerships was developed in 2005 to address the social economic system and to serve communities in Toronto. The mandate is to develop new partnerships, coordinate, manage and create. The first program was to partner with Pathways to Education in response to a new opportunity of creating new pathways for non traditional students. They partner with Goodwill and Fred Victor Mission to help people transition to employment. The work has evolved and they are now designing effective programs and sustaining engagement with community. They had a total of 1,824 clients in 2008-2009 and found there is a need from communities to meet their needs. There are 64 programmes overall.

# Initiatives:

- First Generation Initiatives support to individuals to make transition to post secondary education
- Pre Apprenticeship Initiatives provide education first and then send them into the workforce work with non traditional communities such as early school leavers, newcomers, EI, starts with academic upgrading, then level one training and then help them find roles
- Green Ladders "Youth Build" the Youth Build program started in the USA to provide academic upgrading and skill training to build homes that are vacant. This program is about building youth. One of the partners is with Habitat for Humanity. Youth helping communities develop assets. Focus on leadership development in addition to knowledge and skills.

Q: When hear community we are expecting inclusive, but this is only focused on youth, what about the seniors? Can the seniors be included in these programs?

A: George Brown does partner with agencies to assist with recruiting. They partner with Second Career to retrain individuals who are older. There is a seniors program as well at George Brown College engaging seasoned individuals. There is a range of ages in the programs already.

Q: So are seniors used as mentors?

A: Yes, used as experts to help develop curriculum.

Q: What is the demand for the programs?

A: We are in the development phase and are looking to leverage and launch a Youth Build project for 25 to 30

Q: How do you accommodate the intake or formal process to reach non traditional individuals?

A: Did close to 25 info sessions to talk about the programs, in house and went out to community agencies to talk to people in their environment. Assessments were scattered over days and added assessment dates to accommodate as many people as possible. Work with different divisions who do the academic upgrading to assist and support individuals. Advisors assist with the formal process for individuals.

Q: Would you consider an information session at the St. Lawrence Community Centre?

A: Absolutely. This is how partnerships happen.

Q: What is the relationship with Regent Park?

A: One of the first partnerships was with Regent Park and people are still involved in programs from this area.

Q: Do you still have continuing education programs at George Brown? A: Yes.

Q: What is the cost for the Community Partnership programs?

A: Nothing to qualified individuals. The Program even assists with supplies and even child care costs for qualified individuals.

Q: How do you measure success?

A: Mostly success is determined on numbers of individuals who secure employment or move to full time schooling. Report on different milestones achieved.

Q: It's good if the program keeps individuals out of trouble. A: Yes.

Q: Where does the funding come from?

A: Depends on the project - 90% operates on various Ministry funding.
