2. OPENING OF MEETING

2.4 Board Meeting Highlights

- Jacquie Williams informed the Delegates that the email list is now in good condition and asked Delegates to inform her if there are any changes to emails.

- Q. Was the communication regarding Bob Rae business of the SLNA?
- A. No, but we send it to you for your info.

 - Suzanne Kavanagh updated the Delegates with information from the Board meeting.
 - Glen Murray is hosting a Town Hall meeting on November 17, 2010. This is not an SLNA meeting. More

2.5 Boulevard Parking

As a result of David Crawford's tireless efforts to beautify the neighbourhood, he discovered cars blocking sidewalks and requested a motion from the Delegates recommending a remediation plan to Pam McConnell's office.

- Q. What is boulevard parking?
- A. The land that belongs to the city not the building. Cars are parked on this boulevard. E.g. Frederick Street north of King Street. There is not that much boulevard parking in the St. Lawrence area.
- Q. If we stop them from parking on the boulevard, won't they park on the streets?
- A. They will park in the regular parking garages. Considering having plants in these areas to beautify the area.
- Q. If we want to talk about meaningless space, let's talk about 1 Church Street.
- A. There is a whole piece on greening for the area on the website.

It was resolved to approve the suggestion put forward by David Crawford to support that the Toronto and East York Community Council request the appropriate City departments (in particular Transportation and Planning) to review all current boulevard parking permits in the area bounded by Yonge Street to Parliament Street and the railway tracks to Queen Street. 3. WATERFRONT TORONTO

- Derek Goring, Director Development presented on the happenings on the waterfront
 - History, more industrial, now the needs have changed
 - o 2,000 acres from Dowling to Coxwell
 - This project focuses on revitalization, not redevelopment
 - Improving public transit and reducing urban sprawl
 - It's about quality of place

- o Building the public realm first as can be seen by Sugar Beach
- Sustainable development. All buildings will be LEED Gold certified
- o Planning to implement public transit first.
- Dealing with the soil that used to be light industrial to reuse the existing soil where possible and economically reusing the soil after contaminates removed.
- o Building neighbourhoods for everyone.
- Main role is planning infrastructure and integrating the infrastructure with the public realm.
- Creating intelligent communities by installing fibre optic cables

Projects:

- 2015 Pan Am Games Request for qualifications have gone out to developers for the housing units for the games.
- Underpass Park Going to create a park under the Richmond/Adelaide overpass before the end of 2011.
- Public Art Developers are donating monies to Waterfront Toronto for public art and will be integrated into the public parks.
- Woonerfs Creating streets where pedestrians, cars and bicycles can share the common area.
 This tends to reduce traffic.
- o River City Condominiums Being constructed in 2011.
- o Heinz will be developing land in the East Bayfront area.
- o The city does not own much more of the land in East Bayfront.
- Canada Square to be built east of Queen's Quay Terminal building parking will now be below ground
- Q. When will the Skating Rink at Sherbourne Park be finished?
- A. Done.
- Q. Please provide an update on the Queen's Quay & Cherry Street streetcar projects.
- A. Cherry Street will start construction shortly; Queen's Quay East is a much more complicated and costly project
- Q. Plans to build elementary schools?
- A. Two sites have been identified in West Donlands.
- Q. What about schools for older children?
- A. This is what the school boards have identified.
- Q. First Parliament Site is the Waterfront Toronto involved in this?
- A. No, this is outside of the boundaries, but they are aware of the efforts.
- Q. Will new Community Centres be developed?
- A. Yes, would like to have community centres incorporated in the new developments.
- Q. Are the illustrations on the website?
- A. Yes, some are on the website, but not all.
- Q. Is there a guesstimate of how many more people in this area?
- A. 20,000 to 25,000
- Q. Will Pan Am soccer fields remain?
- A. No, they will not be built for the games.

The Delegates thanked Derek Goring for his time.
