# 4. Committee Updates:

### 1. 51 Division Community Police Liaison Committee (CPLC)

- o Don James introduced Supt. Elizabeth Burns, Inspector Robert Johnson and Staff Sergeant Peter Troup (Community Response Unit)
  - o All 3 officers gave a brief background on how they came to 51 Division
- o Supt. Burns spoke about her focus on communications with the St. Lawrence Community and gave an overview of policing this division. She asked for help from our neighbourhood buildings and residents regarding suspicious activities and noted the importance of the CPLC Complaint form
  - o Staff Sgt. Troup spoke about the importance of the CPLC Complaint form as their best help in focussing police response activity and that the general public is the greatest deterrent for crime
    - o He encouraged people to talk to his officers who we will see often on bikes in the area
  - o TAVIS Anti-violence units (Neighbourhood TAVIS division) will be coming to 51 Division in the near future
