# 3. Board Report:

Dwight Peters stepped down as President and will complete the remainder of his term (one year). Stephen Devine has resigned from the Board.

## 4. Committee Updates:

## **FORTY-ONE**

Steve Lowden updated the group on the community partnership whose function is to bring arts and culture events to the Esplanade community during the Pan Am/Parapan Am Games in order to create connections and celebrate the Games. The group consists of community groups (Jamii, BIA, SLNA), arts groups (St. Lawrence Centre for the Arts, Sony Centre, Young People's Theatre, Prologue, CORPUS), community service providers (the Rec Centre, St. Lawrence Public Library) and individual artists. They initially met in June of 2013 and have been meeting regularly to define and implement plans. Forty-one represent the number of countries represented at the Games. There are three different aspects to the project: the creation of a book based on interviews done by Grade 7/8 school children at Market Lane Public School and St. Michael's Catholic School with a representative in one of the 41 countries; a visual art installation based on the stories and a mural which will provide a lasting legacy of the community connections created.

As the SLNA is a partner in this project, the following motion was presented:

"Be it resolved that the SLNA release \$1,500 from reserves to support "FORTY-ONE" an arts/culture community partnership in support of the 2015 Panam and Parapan Am Games."

#### 5. Guest Speakers:

#### I. Ken White from New Visions

New Visions is a non profit organization that is registered charity. New Visions provides housing, care and support for people with complex physical and development disabilities. They have 15 homes throughout the GTA with 11 in the St. Lawrence Neighbourhood. They support 58 people on a full-time 24 hours basis. They also offer respite services so that parents can take a break from caring for their children.

#### II. Dianne Wintermute - Lawyer at ARCH

- 1.) ARCH is a specialty legal clinic focused on defending and advancing the rights of persons with disabilities in Ontario. In addition to providing summary advice and reference pertaining to legal issues in a wide range of areas, such as accessibility, discrimination, and abuse of persons with disabilities, ARCH has priority areas in which provides legal representation. These areas are attendant services, education, developmental services, and capacity and guardianship, and then access to justice is an overarching framework under which ARCH operates.
  - a. Inclusiveness ARCH's vision promotes a world in which all people with disabilities enjoy social justice and equal participation. Thus, ARCH aims to provide its services in a way ensure our work has an Ontario wide impact focusing on identifying and removing systematic barriers, but we are committed to do this work through a human rights lens, which places the client at the centre. Their approach to disability services moves away from formal mechanisms of determining disability, such as relying determinations made by a medical practitioner. Instead, anyone who identifies with having a disability (and meets the financial requirement) can receive services from ARCH. This is one of the way in which ARCH creates an inclusive environment that is aware of the many ways disabilities can be perceived and experienced, and the diverse ways relevant issues can emerge.

## 2.) ARCH's WORK Priorities

#### a.) Attendant Services

- Attendant services are services provided to people with disabilities to **assist with routine activities of daily living** such as dressing and bathing
- ARCH's work in this area addresses situations where people are being **abused** by those who are providing assistance to them, where the contract for the services **removes the rights** of the person with disability
- Activities

- Conduct law reform, public and continuing legal education and community development projects
- In terms of legal representation, ARCH negotiates with service providers and/or Community Care Access Centres (CCAC), represents people before the Health Services Appeal and Review Board and Divisional Court

**ARCH** does provide representation for individuals. However, their case selection process is more stringent than community clinics. ARCH considers whether there are other legal services available, whether a significant number of people with disabilities would be affect by the outcome of the case, and whether it other things or addresses poverty of persons with disabilities, among the Ontario Disability Support Program, because community clients already provide that service.

Most of the individual client work performed by ARCH is summary advice and referrals. ARCH provides information about the law and about one's right to persons with disabilities no matter their financial situation. If ARCH feels that another clinic, organization, or private bar lawyer would be better suited to handle the case, then they will provide a referral.

- ARCH will provide brief services in certain circumstances. This can include reviewing documents or drafting an application for a client.
- ARCH also intervenes in important cases concerning the rights of persons with disabilities. ARCH has
  represented organizations as intervenes often at the Supreme Court of Canada and many other levels of
  court
- ARCH also serves persons with disabilities through Law Reform projects and by giving submissions to government organizations. For example, ARCH provided submissions to the Ontario government about the AODA.
- ARCH also does public legal education events, where they provide information to community
  organizations and affected organizations about the law and the rights of individuals that must be
  respected. This includes training for lawyers.
