Co-ops:

 discussed the challenges facing Canadian co-ops with Federal operating agreements starting to expire and action being taken

St. Lawrence North Market

- Currently working through the final stages of the design process
- Rough timeline
 - Construction of temporary market this summer (May/June)
 - Demolition (including archaeological work) to start around the end of this year
 - Opening in 2016

Seniors Centre

- o Seniors space to be incorporated in new North Market mezzanine level
- o Location and size of space is being reviewed by staff, approximately 500 sq ft core space
- o Will run as a satellite of the Recreation Centre
- o Consultations on future programming taking place

First Parliament Site

- \$17 million in the 10 year capital plan for the library
- o Design work in 2016, Construction starting in 2017, Open by 2020

 The next meeting of the working group is being finalized for mid-March and includes representation from SLNA and the St. Lawrence BIA, along with City staff and other local resident groups

Berczy Park: Final Public Meeting will be held on Tuesday, March 11

Island Airport: Vote at March 25 Executive Committee Meeting

5. Committee Updates:

- Nominations Committee: Chair Mary McDonald reminded delegates that nominations are open for the Board and encouraged nominations for the Board of Directors at March 26, 2014 Annual General Meeting.
- Events Committee: Guidelines for the Events in the St. Lawrence Neighbourhood were presented and discussed. The group asked that the Committee define what an "event" is as part of their initial work. The group also recommended that the major stakeholders be defined (this would include the St. Lawrence Market BIA, the St. Lawrence Market, the St. Lawrence Rec Centre, local schools, Jamii, other community groups as appropriate). There is also a need to create criteria to avoid subjectivity. Finally, the group emphasized the importance of including as many voices as possible with regard to the events we welcome to the community. The Committee will meet to discuss these points and present an updated document.

With these revisions, it was resolved to approve the amended Event guidelines.
