3. Board Report:

- Berczy Park: The final public consultation on the Berczy Park Revitalization was held March 11, 2014.
- The design for the park has been completed
- Resident in-put led by The Friends of Berczy Park played a major role in planning
- Area residents are satisfied with the outcome
- Construction will begin in the Fall of 2014 and will be completed by the Pan Am Games in 2015
- **Development Committee:** The City's Design Review Panel suggested that the developer for 177 Front Street revisit their design plan to address concerns around density, green space and height before conducting a community consultation
- A design "charette" was suggested as an effective means of engaging the community in consultation
- The SLNA will participate in this important process
- A comprehensive list and information on development in the area is posted on the SLNA web site
- Porter Airlines: Porter Airline's request to expand jet service at Billy Bishop Airport was debated by City
 of Toronto Executive Committee
- The Executive Committee voted in support of staff recommendations to continue to negotiate commitments around critical points of concern with regard to the proposed expansion including receipt of specific details from the Toronto Port Authority and Transport Canada
- Added a stipulation that no more than 25% of all flights in/out of the airport be jets
- The report to council will likely be completed early 2015
- Proposed framework for negotiation will be considered by City Council on April 1
- Events Committee: Still looking for additional volunteers
- First official meeting of the new Events Committee will be held mid-April
- Guidelines will be revised Guidelines as per delegate suggestions. (See Minutes, February 26, 2014
- Jerry Hammock was welcomed as a new member of the committee)

4. Committee Updates:

- St. Lawrence Library: Librarian Dulce Gomez reported the following events will take place at the library (www.torontopubliclibrary.ca)

 - o April 29- Beth Ann Cote, Gifts in the Old, Old Groups Poetry & Songs at 7:00 pm
 - o May 29- Environmental Talk Toronto's Tree Canopy at 7:00 8:00 pm
- **First Parliament Site Working Group:** David Crawford reported the Group has had 3 meetings to discuss the site's history, archeology, concept and design
 - Site is currently undergoing extensive environmental testing and likely continue until August. Testing has to be completed before undertaking the design

- o A design concept for the whole site will be prepared in 2015 and will include the expanded 25,000 sq.ft. St. Lawrence Branch of the Toronto Public Library
- o Public consultations will be held in 2015 2016
- o Parks and Recreation and the Ontario Heritage Association will be conducting public consultations around the planning process
- o Project completion date is 2019
- St. Lawrence Heritage Conservation District (HCD) Study: David Crawford reported that the study was moving along with a possible next meeting date of April 14, 2014
