4. Community Updates:

Tom Davidson from Ward 28 Councillor Pam McConnell's office

- Market Street there was discussion of appropriate times for patio operations; patios are currently open until midnight and work is being done to balance the needs of residents and businesses; the City has regulations for "boulevard cafes" that prohibit amplified music; Yonge/Church "Residential Neighbourhood" signs may reduce/deter noise, especially when events have concluded.
- Lower Sherbourne the underpass is being rehabilitated; the City is supplementing light features at the site from July to the end of construction season (Doug Maybank pointed out that the GO Transit website is full of information regarding the underpass work; Wally Simpson said that garbage is not being picked up on the railway embankment and has taken pictures of it)
- Backstage Condominium's pedestrian walkway will officially be part of the PATH system
- Relocated Farmers' Market at The Esplanade/Jarvis/Market parking lot there was a question about where the loading/unloading dock would be (Alan Seymour may know more)
- 60 Colbourne an issue with dead trees was mentioned and Tom suggested contacting 311 and the Forestry Department would take action

5. Guest Speaker: Barb Pimento of George Brown College's WAVE Programme

- WAVE is Wellness, Applied Research and Visionary Education and it is a health clinics for the public.
- WAVE is housed in George Brown's waterfront campus, which brings together all of GBC's Health Sciences in one building, located at 51 Dockside Drive
