Ani and Richard noted that the SLNA's email address will remain the same, but the website address will change. There will be an advertising campaign in the community to announce all the changes.

Ani and Richard took into consideration Sherri Russell's recommendation to copyright the website and logo.

# 7. Other Business

## a) The Community Bulletin

Frank Touby announced that *The Community Bulletin* is offering the SLNA a half page of free space for community news in its monthly newspaper. Delegates applauded.

## b) Environment Day

Dan O'Leary announced that Councillor Pam McConnell's annual Environment Day is scheduled for Saturday, April 28, at the park at Sherbourne and The Esplanade. Compost will be available for pickup. People can drop off old computers, batteries, tires, and paint for recycling. Energy efficient products will be available. A replanting project for children will take place that day.

# 7. Greetings from Political Representatives

## a) George Smitherman (MPP)

The Chair welcomed John Kennaley of George Smitherman's office. John expressed regrets that George Smitherman was unable to attend tonight as he is conducting two seminars across metro Toronto concerning the most recent Ontario budget.

As requested by the Executive, John gave an update on community health centres (chc's). The Ontario government is committed to increasing the number of chc's from 54 to 76. The SLN and east of the SLN is being examined to determine if a new chc will be established here. In response to Delano Brown, Ani stated that she is working with Derek Norridge to determine if the website can be made readily accessible to people who are visually impaired.

Catherine Limbertie offered to look into French translation of the website.

Delegates thanked Ani Kounavis and Richard Kwong for donating their time to this project. Delegates thanked Frank Touby of *The Community Bulletin* for donating the existing website to the SLNA. Ani thanked Joan Campbell as an advocate for the new website and as a valued continuing member of the Communications Team.

# c) Garbage Clean-up

New Delegate Maria Corfe asked the SLNA to approach government to clean up the garbage in the neighbourhood, and particularly to provide more garbage cans. She asked to be included in any related intiatives. The Chair advised that the SLNA's intention is to have a clean and healthy neighbourhood and added that her concern was noted by Tom Davidson of Councillor Pam McConnell's office, present at the meeting.

Elisabeth Ecker asked that the City ensure that plastic bags in City garbage cans be weighed down so they do not turn inside out in the wind. The Chair stated that the Executive will raise the matter with Parks & Recreation.

The constituency office is publicizing its contact information so that people, especially new moveins, and particularly immigrants, can learn what help is available to them in areas including healthcare and drivers' licenses. Joan Campbell offered that the SLNA publish the MPP's contact information on the SLNA's website.

Paul Smith advised that a committee is looking into establishing a Youth Academy of the Arts School in the neighbourhood. They plan to open in September 2007, and are seeking the donation of 2,000 square feet of space. John offered to determine what funding for the school might be available through the provincial government. Sylvia Grimson distributed flyers.

Ewa Jarmicka asked whether George Smitherman will visit the SLN this summer. Paul Smith advised that he has been invited to the SLN's Canada Day celebration at St. James Park.

The Chair thanked John Kennaley for his report. Delegates applauded.

#### b) Hon. Bill Graham (MP)

No representative was present.

#### c) Councillor Pam McConnell

The Chair and Delegates welcomed Councillor Pam McConnell, who arrived at 8:42 p.m. She described the work that her office is doing in conjunction with SLNA's 20-point plan:

#### Heritage and Conservation:

The City is sending out a request for proposals (rfp) for a heritage interpretation plan in two parts: a heritage interpretation plan for Old Town Toronto and a plan for lighting neighbourhood buildings.

#### Greening and Sustainability:

City Council has approved bicycle lanes for Yonge Street. This is part of a plan to connect to a new neighbourhood to be called the Waterfront, a neighbourhood for walking and cycling like the SLN. This was accomplished without reducing lanes of traffic. The Yonge Street Promenade is in its final stages of planning. The SLNA and its Development Committee were instrumental in bringing forward the notion that development on Yonge Street had to connect with the SLNA through a pedestrian conduit.

Underpasses are being cleaned.

# 9. Concluding Remarks — Paul Smith

## a) Downtown Alternative School

Paul Smith introduced Leo Agosta. Leo advised that he would like to provide a bridge between the three local schools (Downtown Alternative School, St.Michael's Catholic School, and Market Lane School) and the SLNA so that the schools become more integrated into the association. A community meeting was held recently to present a plan for an office building to be constructed at the foot of Jarvis Street. Attendees, including representatives from GWNA, expressed approval that the site will include good public spaces and a sustainable building (to be certified LEEDS gold).

Councillor McConnell praised the SLNA for setting a framework for the rest of the city in emphasizing the importance of how each new building fits into the neighbourhood. "The work you have done in terms of sustainability has now been embedded into many other communities." Delegates applauded. Special thanks was given to Cam Miller.

#### Social Infrastructure:

The SLNA and particularly Connie Yang have championed the establishment of a seniors' centre in the SLN. 70 The Esplanade has offered space for the centre for five years. The City will pay heat and electricity. The centre will be run entirely by SLN seniors. Councill McConnell expressed hope that the centre becomes a model for the rest of the city. Connie Yang noted that she and Joan Campbell work together as co-Chairs of the Seniors Project.

Councillor McConnell stated, "We know the SLNA is the most successful community in Canada." She concluded, "I am really proud you chose me as your representative and hope I do you justice at Council." Delegates applauded.

Joan Campbell asked for an update on funding for a study on the heritage conservation district. Councillor McConnell advised that due to changes in regulations, Section 37 funds can no longer be used, and that the study will need to wait for Section 44 moneys. The next Section 44 funds available will be red flagged for that project.

The Chair thanked Councillor McConnell for her report.

Leo announced that the Downtown Alternative School (DAS), located at Jarvis and The Esplanade on the second floor above the Golden Griddle, plans to renovate the schoolground out front that it shares with St. Michael's Catholic School. He distributed a plan for the renovation, which includes a greening project, a peace garden with native plants, seating areas, cobb container gardens, and an outdoor theatre. He described the initiative as a community building project, and noted that the schoolground will still contain a very large play area. He asked for volunteers and for funding. Renovations might start as early as the end of April and will take place over the next couple of years.

DAS's annual bazaar, its main fundraising event, will take place on June 9. The SLNA's website and *The Community Bulletin* will announce details. The school accepts donations for the event. Leo offered to speak more on the bazaar at the SLNA's next Delegates meeting.

b) Outgoing Executive

Paul Smith announced that three very devoted and dedicated volunteers to the SLNA are leaving their positions on the Executive: Joan Campbell, Connie Yang, and Hugh-Francis Burns. He asked Delegates to thank them for their tremendous efforts. Delegates applauded. Bruno Leps handed out gifts and cards to each on behalf of the SLNA.

# c) SLNA meeting location and set-up

Ronny Yaron asked for volunteers to set up the meeting space and arrange for refreshments for future Delegates meetings as Connie Yang is no longer available to do so. She noted that Connie, as a member of OWN, has been providing the meeting space, and noted that the SLNA will need to book a location, either OWN or elsewhere, for future meetings. Delegates applauded Connie's work.

## Adjournment

The Chair adjourned the meeting at 9:08 pm.

The SLNA acknowledges the St. Lawrence Market Complex for sponsoring this evening's refreshments, and OWN for hosting tonight's meeting.
